7. Team Tournament Structure:	Pool Play: <ul style="list-style-type: none">- Pool play to Bracket Draw Playoffs. Format will depend on the number of teams entered.
8. Divisions:	Competitive <ul style="list-style-type: none">- No age restriction.- Competitive, local A players. Semi-Competitive <ul style="list-style-type: none">- No age restriction.- Recreational, local B & C players.

9. Team Regulations & Requirements:

Maximum 1 entry per player. Players may not play for multiple teams or in multiple divisions due to time constraints.

Competitive Division (MAXIMUM 8 TEAMS) - \$600 per Team.

- Minimum 8 players. **Additional \$50 per member after 8 members.**
- One Team Captain.
- Minimum 2 women.
- At least 2 women must be included in the line-up for each tie.
- Events per tie:
 - Doubles 1
 - Doubles 2
 - Doubles 3
 - Doubles 4
- Line-ups must be ranked from strongest to weakest.
- Players may only play one match per tie.

Semi-Competitive Division (MAXIMUM 16 TEAMS) - \$600 per Team.

- Minimum 8 players. **Additional \$50 per member after 8 members.**
- One Team Captain.
- Minimum 3 women.
- At least 3 women must be included in the line-up for each tie.
- Events per tie:
 - Doubles 1
 - Doubles 2
 - Doubles 3
 - Doubles 4
- Line-ups must be ranked from strongest to weakest.
- Players may only play one match per tie.

MAXIMUM 20 TEAMS TOTAL (SEMI & COMPETITIVE COMBINED)

10. Team Match Regulations:
NEW REGULATIONS

- 4 Matches per tie:
 - Doubles 1
 - Doubles 2
 - Doubles 3
 - Doubles 4
 - (Tie Breaker) 3v3
- Each match is best of three games to 15 points.
- 1 point is awarded for each match won.
- If the Team Match is tied at 2-2 after all doubles matches have been played, the Team Match will go to the Tie Breaker 3 versus 3, one set to 15 points, no deuce.
- The Team with the most points after all matches have been played wins the Team Match.

- Pool Play: Must play all matches.
- Playoffs: Must play all matches unless there is a time constraint determined by the tournament organizers.

11. 3v3 Tie Breaker:
NEW

- Teams must be determined during the line-up submission
- Each team of 3 must have a minimum of 1 female player.
- There will only be 1 server, and 1 receiver, just like regular doubles.
- The 3v3 Tie Breaker will be played to 15 points, no deuce.
- All other regular doubles rules apply.

<p>12. Order of Play: *NEW*</p>	<ul style="list-style-type: none"> - First Two Matches: Doubles 4 & Doubles 2 - Third & Fourth Matches: Doubles 3 & Doubles 1 - If Matches are tied: 3v3 Tie Breaker
<p>13. Condition of Play:</p>	<ul style="list-style-type: none"> - Acceptable badminton clothing must be worn by players. - Players must be prepared to go on court at the start of the tie; there will be a 10-minute default rule in effect. This applies to all remaining matches in a tie as well.
<p>14. Entries & Deadline:</p>	<ul style="list-style-type: none"> - All entries must be made online at www.PacificCup.net and full payment must be made online through Paypal by July 10, 2026. - Late entries and other forms of entry WILL NOT BE ACCEPTED. - Full team roster MUST BE submitted at the time of entry. - EACH TEAM MUST HAVE A TEAM CAPTAIN. - Team Captain MUST complete and submit the team form to info@pacificcup.net - Team form is available to download at www.pacificcup.net. - IMPORTANT: Do <u>NOT</u> wait until the last minute to sign up as we expect this tournament to be full before the entry deadline.
